What Happened?

- Most fixed-income sectors generated negative total returns but positive excess returns during the month
- US Treasury yields rose as persistent inflation data, in conjunction with hawkish pre-Federal Reserve (Fed) Open Market Committee comments from the Fed, led market participants to price a higher-for-longer policy-rate backdrop
- The Fed kept rates on hold as it awaits more evidence of inflation falling sustainably to its 2% target

Performance Highlights

Contributors

- Exposure to non-agency RMBS helped relative results. Housing data releases have been strong, and the structural housing supply shortages continued to act as a powerful tailwind for home prices.
- Positioning in Treasury Inflation-Protected Securities benefited relative performance following sticky US inflation data

Detractors

- Duration and yield-curve positioning represented the biggest detractor from relative returns as US Treasury yields rose
- An overweight to agency MBS hurt relative performance as interest-rate volatility rose



Monthly Fund Commentary

Current Insight and Positioning From Wellington Management

- Corporate fundamentals appear to have stabilized, although margins are likely to come under pressure as pricing power subsides
- We maintain an underweight to investment-grade credit due to better observed opportunities in various out-of-benchmark sectors, including high-quality securitized credit (residential housing benefits from low supply), BB high yield (more insulated from default risk than CCCs), and select emerging markets (we limit exposure to high-conviction turnaround stories)
- The Fed is biased toward policy accommodation and will likely guard more against downside growth and labor market concerns compared to upside inflation risks. We are positioned long duration versus the benchmark.
