Adaptive Allocations

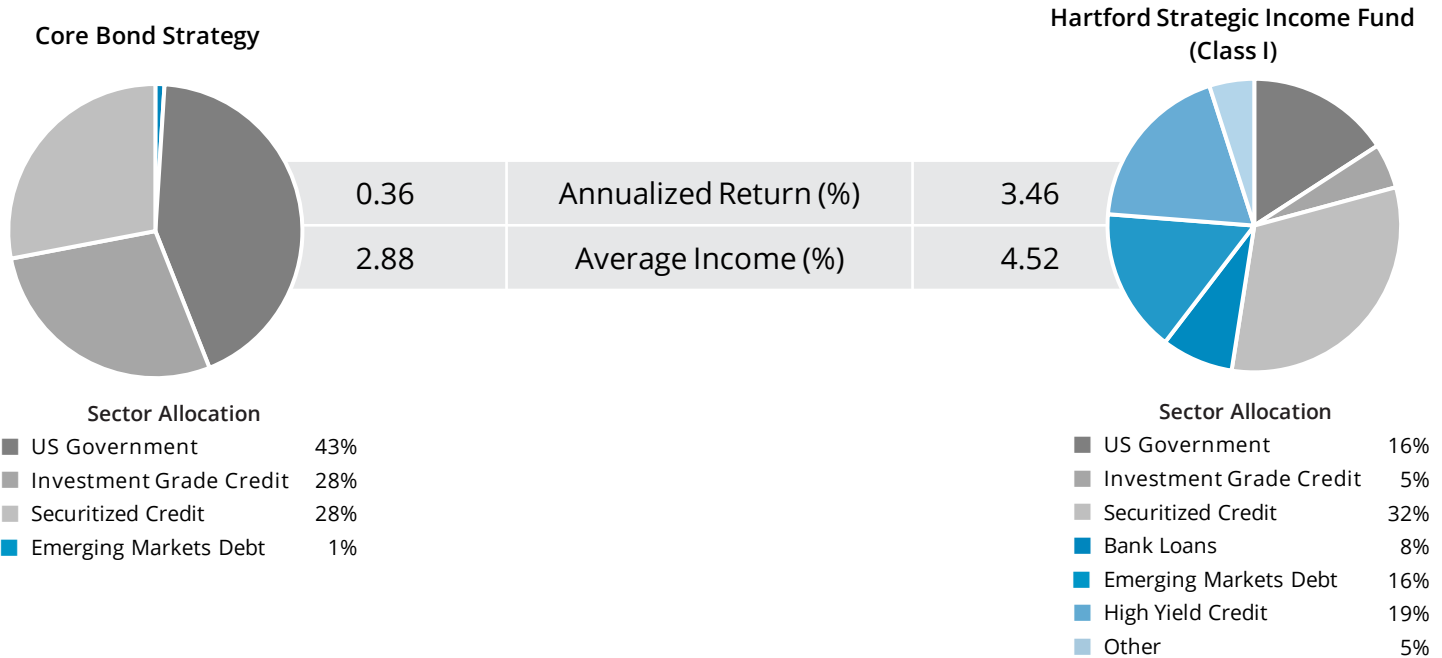

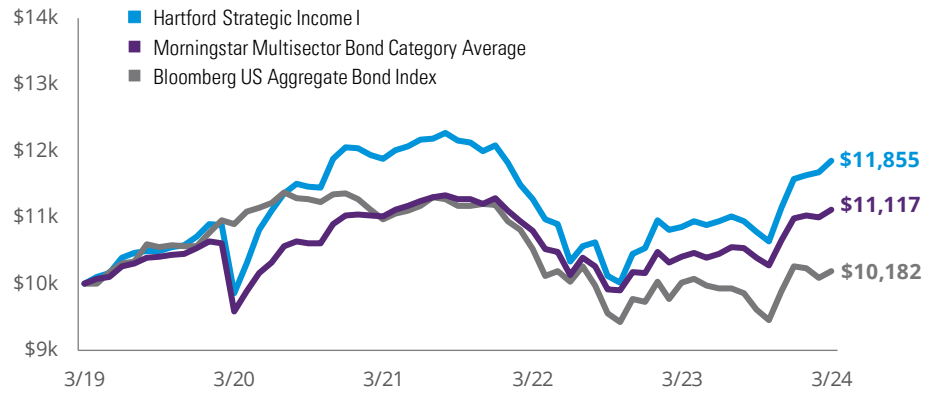
