We look for companies that meet the following criteria:

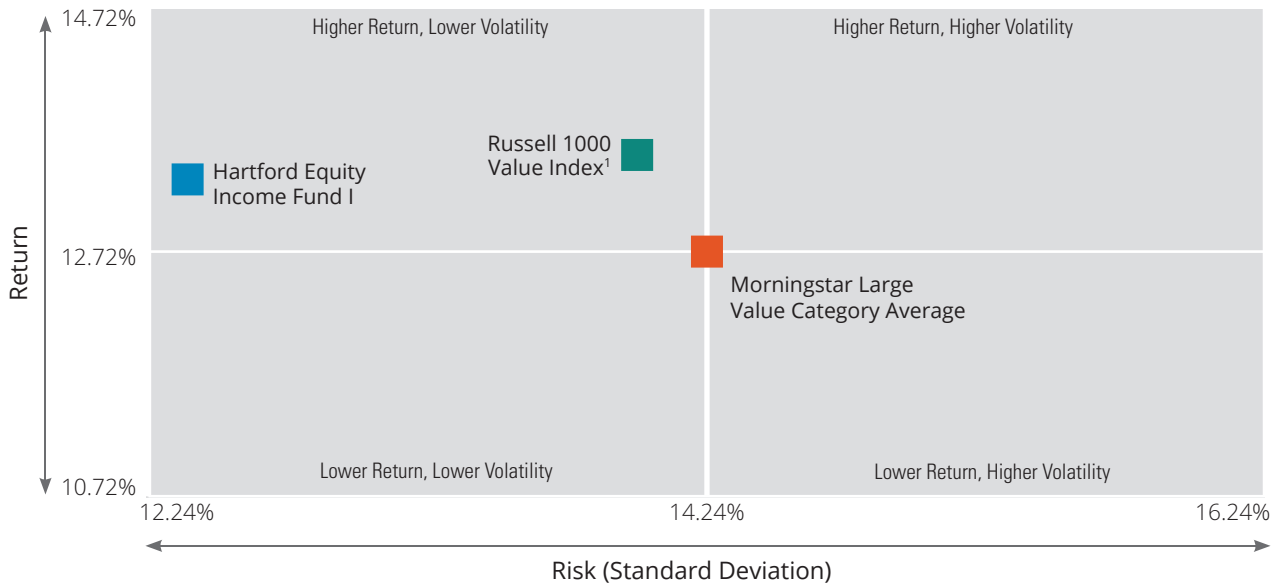
1. Sustainable and/or growing dividends (or plans to initiate a dividend)

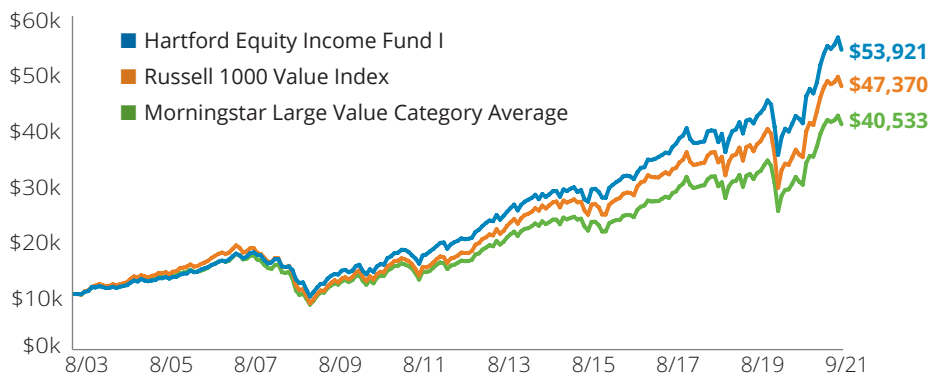
